

Under Article 1020 Paragraph 1 Line 2 of Maritime Act (Official Gazette no. 181/2004)  
Government of the Republic of Croatia enacts the following:

**ORDINANCE**  
**ON THE AMENDMENTS OF THE ORDINANCE**  
**ON THE REQUIREMENTS FOR THE ARRIVAL AND STAY OF FOREIGN YACHTS AND**  
**BOATS DESIGNED FOR SPORT AND PLEASURE IN THE INTERNAL WATERS AND**  
**THE**  
**TERRITORIAL SEA OF THE REPUBLIC OF CROATIA**

**Article 1**

In Article 4 of the Ordinance On The Requirements For The Arrival And Stay Of Foreign Yachts and Boats Designed for Sport and Pleasure in the Internal Waters and the Territorial Sea of the Republic of Croatia (Official Gazette no. 2/2005) ( hereinafter: Ordinance) Paragraph 1 Line 2 after words „ Harbourmaster's Office “ words „or Branch Office“ are added.

**Article 2**

Article 7. of the Ordinance is changed as follows:

- „(1) The master of the floating craft whose crew or passengers are to be replaced during its navigation in the Republic of Croatia shall fill in and duly endorse the List of Persons at the authorized Harbourmaster's office or its branch office.
- (2) The List of Persons is a list consisting a data on persons who may stay on board the floating craft mentioned in Paragraph 1 of this Article during the period of validity of the licence disc/sticker/vignette and is filled out on the form given in Appendix 2, constitutes the integral part of the Ordinance herein.
- (3) List of Persons shall be endorsed by delivering the vignette counterfoil.
- (4) The number of persons shown on the List of Persons specified in Paragraph 2 of this Article shall not exceed double the number of persons who may be carried on board such a craft increased by 30% of the number of persons the craft may carry.
- (5) The number of persons who may be carried on board the craft mentioned in Paragraph 4 of this Article shall be determined in accordance with the registration papers of the same floating craft or when registration papers do not state this number it shall be determined pursuant to Regulation on Boats and Yachts and Technical Rules for Statutory Certification of Boats and Yachts.
- (6) List of Persons shall not include persons staying on board the craft in port or on anchorage.
- (7) List of Persons may be completed with the issuance of the vignette or it may be filled consecutively provided the person is listed prior to its embarkment.
- (8) If the List of Persons is filled consecutively, each entry shall be duly endorsed at the authorized Harbourmaster's office or its branch office.
- (9) Should it be found during the inspection survey that the floating craft specified in Article 1 of this Ordinance is carrying a person who is not shown in the List specified in Paragraph 1 and 2 of this Article, or that the List has not been suitably endorsed with the vignette counterfoil, or that there is no List, such voyage shall be considered as unlawful coastal trade (“cabotage”).

**Article 3**

The List of Persons Form specified in Appendix 2 of the Ordinance is replaced with the new Appendix 2 which constitutes the integral part of the Ordinance herein.

**Article 4**

This Ordinance shall come into force as of the eighth day of the date of its publication in the  
Official Gazette of the Republic of Croatia.
